SUPPLEMENTARY INFORMATION

In accordance to the Charter of Harvard Club of Poland:

- Graduates and persons significantly connected with Harvard University, both citizens of the Republic of Poland and foreigners (even if they do not live in Poland) are able to be ordinary members of Harvard Club of Poland.
 - (§ 8 p. 2)
- 2) Ordinary member status can be obtained as a result of:
 - a. Submitting the membership application in writing or via e-mail to the president of the Club or any member of the Club's Board;
 - b. The approval of the submitted application by the Club Board (§ 9 p. 1)
- 3) Supporting members of the Club can be natural persons or corporate entities, that contribute in a financial, academic or other substantive manner to the implementation of Club goals (§ 8 p.3)
- 4) Supporting member status can be obtained as a result of:
 - a. Submitting the membership application in writing or via e-mail to the president of the Club or any member of the club's Board;
 - b. The approval of the submitted application by the Club Board (§ 9 p.2)

According to the Resolution taken on the 1st of March 2017 by Board of the Harvard Club of Poland, the criteria and process of approving submitted applications are listed below:

- 1) The status of Ordinary Club Member can be granted to:
 - a. Harvard University graduates, who have obtained an academic title at Harvard University and on that basis they are in the Harvard Alumni Association database as alumnus;
 - b. Residents of Harvard University who spent at least one year for academic purposes;
 - c. Persons who are significantly connected with Harvard University.
- 2) Status of Supporting Club Member is granted to both legal persons and corporate entities which declare or contribute in financial, academic or substantive manner to implement Club goals. In particular, the status can be granted to:
 - a. Persons who have completed a Harvard University course and received a certificate of completion from Harvard University and they are listed in the Harvard Alumni Association database as an associate member;
 - b. Persons who completed a Harvard University course and received a certificate of completion from Harvard University and are not listed in the Harvard Alumni Association database;
 - c. Residents of Harvard University who spent less than one year for academic purposes;
 - d. Persons who are in other way associated with Harvard University;
 - e. Students of Harvard University.
